i) In view of the particulars given in the Para 1 above, the project proposal interalia including Form-7 were submitted to the SEIAA under the provision of Para 11 of the EIA notification 2006 and its subsequent amendments. Details in Form 7 can be accessed on PARIVESH portal by scanning the QR Code above.

ii) The MoE&F, GoI, New Delhi issued EC to the project vide Order dt. 17.10.2006, EC-Expansion vide order dt. 26.04.2021 issued by SEIAA, TG to M/s. PMC YM - Pharma (P) Ltd., Sy. Nos. 506 (Part) & 507 (Part), Koyyalagudem Village, Choutuppal Mandal, Yadadri Bhuvanagiri District, Telangana. The project obtained CFE vide order dt:13.08.2019 & CFO vide order dt:05.06.2025 issued by TGPCB.

iii) Now, M/s. PMC Pharmaceuticals India Pvt. Ltd., vide Proposal No. SIA/TG/IND3/547902/2025, dt: 22.08.2025 informed that M/s. PMC YM - Pharma (P) Ltd., incorporated and registered under the Indian Companies Act, 1956 has changed its name to M/s. PMC Pharmaceuticals India Pvt. Ltd., and submitted Certificate of Incorporation pursuant to change of name letter dt:28.03.2024 issued by Registrar of Companies, Ministry of Corporate Affairs, GOI. The project proponent submitted copies of Undertaking on Rs. 100/- Stamp paper dt. 07.08.2025 by M/s. PMC Pharmaceuticals India Pvt. Ltd., for complying all statutory stipulations as per EC. Hence, it was requested to change the project name in the EC as M/s. PMC Pharmaceuticals India Pvt. Ltd.

iv) The above issue was examined by the State Level Environment Impact Assessment Authority (SEIAA) in its meeting held on **26.08.2025** discussed in detail and approved the project for transfer of EC dt: 17.10.2006 issued by MoEF&CC, GoI and EC expansion dt: 26.04.2021 issued by SEIAA, TG.

v) In view of the above SEIAA hereby accords Transfer of EC to M/s. PMC Pharmaceuticals India Pvt. Ltd, under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions issued vide EC order dated 17.10.2006 and Expansion of EC order dt: 26.04.2021.

vi) The SEIAA, Telangana transfers the EC order dt: 17.10.2006 and transfer of EC (Expansion) order dt: 26.04.2021, in the name of M/s. PMC Pharmaceuticals India Pvt. Ltd, with all terms and conditions stipulated therein remain the same, along with the following additional conditions:

The Project Proponent is under obligation to implement the commitments made in the Environment Management Plan, which forms part of the prior EC issued vide dated 17.10.2006 & amendments thereof and Expansion of EC order dt: 26.04.2021.

The non-compliance / violations, if any, committed by M/s. PMC YM - Pharma (P) Ltd., of the above mentioned unit is the sole responsibility of M/s. PMC Pharmaceuticals India Pvt. Ltd.

vii) The SEIAA may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory.

viii) The SEIAA reserves the right to stipulate additional conditions, if found necessary.
